**Important Information about the Continuation of the Optional Attendance Zone**


Dear Optional Zone Parent/Guardian:

I am pleased to inform you that the Board of Education of the Great Neck Public Schools will continue the optional secondary school attendance zone for the 2015-2016 school year; the continuation of the program is in the best interest of our school community. Students living in the E.M. Baker and Saddle Rock attendance areas, currently in grades 5-11, and currently zoned to attend South High School and South Middle School, may elect to attend North High School or North Middle School. (You may click on the "Optional Attendance Zone Map" link to determine if you reside in the optional attendance area.) Please note: all students who take advantage of this option are eligible for transportation if they are beyond the "walker" limits of the chosen school.

A copy of the District's January calendar appears on the reverse side of this letter. You are welcome to attend middle and high school events as a means of learning more about each of our secondary schools prior to making your Optional Attendance Zone decision.

Regardless of whether or not the optional attendance zone continues in future years, younger siblings will be able to attend the same secondary schools as their older brothers and sisters when they reach middle or high school age. Should you elect to have your child attend North High School or North Middle School, please complete, sign, and return this form by Friday, January 16, 2015. **Note that you must submit this form even if your child's older sibling(s) are already attending North High School or North Middle School.** Written confirmation approving your request will be sent in writing on or about February 6, 2015.
