**Optional Attendance Zone Information**


**Important Information about the Continuation of the Optional Attendance Zone**

The Board of Education of the Great Neck Public Schools is pleased to offer an "Optional Attendance Zone" choice to qualified students who will enter 6<sup>th</sup> grade in the fall of 2018; it is in the best interest of our school community to do so. Current 5<sup>th</sup> grade students living in the E.M. Baker and Saddle Rock attendance areas and who are zoned to attend South Middle School may elect to attend North Middle School instead. **You are receiving this letter because you are entitled to take advantage of this opportunity.** All students who take advantage of this option are eligible for transportation if they reside beyond North Middle School's "walker" limits, and their younger siblings will be provided with the same choice when they reach 6<sup>th</sup> grade.

A copy of the District's January calendar appears on the reverse side of this letter. You are welcome to attend middle and high school events as a means of learning more about each of our secondary schools prior to making your Optional Attendance Zone decision. (Note that the South Middle School meeting for the parents of incoming 6<sup>th</sup> graders has been moved to March 19<sup>th</sup> 2018 so that all Optional Zone choices will be complete prior to the event.)

Should you elect to have your child attend North Middle School, please complete, sign, and return this form by Friday, February 2, 2018. **Note that you must submit this form even if your child's older sibling(s) already attend North High School or North Middle School.** Written confirmation approving your request will be mailed on or about February 16, 2017.
